Minutes of the Faculty Meeting

September 11, 2001

The meeting was called to order at 5PM by Prof. Michael Payne. He welcomed new colleagues as well as new Trustee committee chairs, including Lee Hamilton as the new Chair of the Board of Trustees. He noted some upcoming opportunities to interact with Trustees and reminded the Faculty of its important function as a governing body. He also noted the passing of former Bucknell colleagues Charlie Walker and Hulda Magalhaes.

Announcements by the President

President Rogers introduced new vice-presidents Steve Bowen, Jo-Ann Lema, Charlie Pollock, and Bob Kallin. He also thanked Interim Deans Mark Padilla and Jim Orbison for their continuing service, as well as that of Wayne Bromfield as interim General Counsel. He reported positive reaction to his recent fundraising tour and noted the continued effort he will be giving to fundraising in the upcoming year. Building projects are on time and on budget. The planning process is getting underway, which will involve every constituency in the university. He ended his remarks with the hope that many faculty will participate in the United Way campaign.

Introductions of new faculty and selected professional staff ensued (see attached list).

The President then turned to members of his staff to answer several questions that had been submitted in writing (see September 2001 agenda for full text). The first question referred to the poor condition of Vedder Hall and asked about improvement plans. Vice-President Lema responded that Vedder and Hunt Halls are scheduled to be renovated in the next few years, and that earlier renovation plans were set aside in favor of refinishing Coleman Hall and other projects. Temporary improvements have been made, and most residence halls are in very good condition. She regretted that faculty moving into Vedder this past summer during Coleman renovations were not made aware of the conditions.

The second written question dealt with conflicts between academic and athletic schedules early in this semester (see September 2001 agenda for full text). Vice-President Pollack agreed that there had been more than the usual number of conflicts this semester and that senior athletic staff had discussed this with coaches. Mr. Pollack and Director of Athletics John Hardt assured the group that the department adheres to an "academics first" policy and that adherence to this policy is part of coach evaluations. Mr. Pollack said that he favors rigorous enforcement of existing policies rather than new policies. In response to a question, he reiterated that Athletics staff are directed to support study-abroad plans of student athletes. Academic/athletic policies are reviewed with staff but should probably be made more visible on the Bucknell website. He was not aware of any policy restricting

travel of first-year athletes. Interim Dean Padilla added that the faculty owns the academic schedule and that the deans are happy to serve as liaisons between faculty and coaches. He also noted that many conflicts arise with extracurricular events other than athletics.

Prof. Peter Kresl asked about the impact of Saturday evening football games on events in the Weis Center; Prof. Marty Ligare also expressed concern about the effect of light pollution on activities at the Observatory. President Rogers had not considered these issues and will look into them.

Announcements by the Chair of the Faculty

Prof. Payne announced that the current planning process will fold into our Middle States (accreditation) review taking place in two years. He promised full engagement of the governance system, and that the University Council will serve as the steering committee, as per their charge as stated in the Faculty Handbook. He assured several questioners that the role of the University Council (and the faculty members, who comprise the Faculty Council) was not to make the substantive planning issues, but to organize the procedure.

Old Business

The Committee on Planning and Budget introduced a revision of its Faculty Handbook amendment, that was first introduced in the April, 2001, meeting (see April 2001 Minutes for that wording).

The Committee on Planning and Budget moves that its membership be expanded to include: one member of the salaried staff other than voting members of the faculty and direct reports of the president or vice-presidents, selected by vote of those eligible to serve, in an election organized by the Administrative Forum; and two members of the hourly staff selected by vote of those eligible to serve, in an election organized by the Support Staff Forum.

Prof. Bill King, chair of CPB said that the revised motion clarified wording in the first version. The intent was to include representatives of both hourly workers, and professionals such as computer center personnel. Prof. Matt Silberman wondered if the additional members weakens the faculty voice. Prof. Andrea Halpern pointed out that the revised motion was not just a clarification. In the first version, any salaried worker below the level of dean was eligible for CPB membership. In the revised motion, all direct reports to vice-presidents would be excluded (for example, the Director of International Studies). She wondered if this was intended or not. Prof. King said this was not the intended effect of the revision. Dean Padilla noted that many university constituencies overlap.

Prof. Payne, sensing the group was not ready to vote, asked for and received a motion to table this issue until the next meeting. The final item of business was a request for additional nominations to CAFT. Hearing none, the meeting was adjourned at 6:30 PM.
